## **ASSESSMENT DOMAIN**

#### **1. PRIMARY PURPOSE OF THE PROJECT**

The primary purpose of building the Oba Adejugbe Builders market is to create an organized and efficient system for the exchange of goods and services, which, in turn, contributes to economic development, innovation, and the overall well-being of individuals in Ekiti State. Markets play a crucial role in facilitating economic transactions and fostering economic growth.

## 2. ALIGNMENT WITH THE COUNTRY'S NATIONAL CLIMATE-CHANGE MITIGATION AND ADAPTATION TARGETS

Environmental and Social Impact Assessment was carried out in respect of the project to ensure its adherence with the National Climate Change Policy (NCCP) 2021. In-situ analyses were conducted for some parameters of surface water, while other parameters and groundwater were obtained from laboratory analysis.
